Nomura Issues US Dollar Senior Notes

Tokyo, July 7, 2020 (New York, July 6, 2020)—Nomura Holdings, Inc. today announced that it has finalized the terms of its US dollar senior notes (the “Notes”) as set forth below. The Notes are being offered in a global offering outside Japan including a public offering under a shelf registration statement in the United States. Nomura will be subject to the Japanese Total Loss-Absorbing Capacity (TLAC) standard from March 31, 2021. The Notes are expected to qualify as TLAC-eligible debt.
